Market Update

Nifty 22,011.95 172.85 (0.79%) Sensex : 72,641.19 539.50 (0.75%)

- Equity benchmark Index climbed up nearly 1% along with a smart rally from mid-cap and small-cap stocks. US Federal Reserve signaled • three interest-rate cuts likely this year despite an uptick in inflation. As a result, the global markets posted solid gains. Overnight, US market ended record high as traders welcomed the news that the Federal Reserve still saw three interest rate cuts this year. Asia n markets soared 2% each and European markets gained 1% each to an all-time high. Both US 2-year Bond Yield and Dollar Index cooled down from higher levels.
- All the Nifty major sectors recorded handsome gains while beaten-down sectors like mid-cap, small-cap, realty, PSU Banks and metal stocks were prominent gainers today (surged between 2-3%).
- Nifty advanced 172 points or 0.8% to close at 22011 against the previous day's close. India Vix fell over 7% to close at below 13 level.

Technical Outlook:

- Nifty index opened gap up near 22000 zones and held at the higher zones followed by a mid-day fall to 21941 which was later made up in • the next half. It managed to close above 22000 zones with gains of around 170 points. It formed a small bodied Bullish candle on daily scale and support based buying was strong.
- Now it has to continue to hold above 22000 zones for an up move towards 22122 then 22222 while on the flipside, support is placed at • 21850 then 21700 zones.

Derivative Outlook:

- Nifty future closed positive with gains of 0.95% at 22118 levels. Positive setup in Muthootfin, Poly Cab, BHEL, Jindalstel, Siemens, BEL, HAL, Naukri, IRCTC, Voltas, DLF, Cumminsind, SRF, ICICIPru, NTPC, Coal India, Lupin, Indhotel, ABB, Oberoirlty, Zydus Life, Indigo, Bajaj Auto and LT while weakness in Petronet and HDFC Life.
- India VIX was down by 7.13% from 13.47 to 12.51 levels. Volatility cooled off and paved way for the bulls from crucial support zones.
- On Option front, weekly Maximum Call OI is at 22000 then 21500 strike while Maximum Put OI is at 22000 then 21800 strike. Call writing is seen at 22000 then 22500 strike while Put writing is seen at 22000 then 21800 strike. Option data suggests a shift in trading range in between 21500 to 22500 zones while an immediate trading range in between 21650 to 22000 zones.
