

MOSt MARKET ROUNDUP



Market Update



Nifty: 22,753.80 111.05 (0.49%) Sensex: 75,038.15 +354.45 (+0.47%)

- Ahead of US key Inflation data today, equity benchmark Sensex surged half percent to close above the 75000 mark for the first time and Nifty ended a record high of nearly 22800 level. Both Bank Nifty and Nifty mid-cap Index posted solid gains to close on a new all-time high. Metal, chemical, oil & gas, FMCG, and NBFC stocks were major gainers today. Rally in the global markets, forecast of normal monsoon in India, strong domestic micro data, and cooling down oil price from a 5-month high boosted the market sentiment.
- Chemical stocks witnessed fresh buying in the hope of good quarterly results. Jubilant Ingrevia surged 11% to close at Rs543. SRF, Atul Ltd, Gujarat Fluorchem, and Deepak Nitrite gained between 5-7%. Northbound journey continued on metal stocks due to a surge in copper price to a 15-month high and soaring aluminum price on London Metal Exchange. Nifty Metal Index gained 1%. Vedanta surged 7% to close at Rs361. Both NMDC and Hindalco gained 5% and 2.5% respectively

Technical Outlook:

- Nifty index opened positive and remained afloat in the entire session. Lacklustre move took over for most part of the day with some
 momentum towards the end. Index moved in a range of 100 points and touched a fresh all time high of 22775 levels.
- It formed a small bodied bullish candle on daily frame and has been making higher lows from the last four sessions to close with gains of 111 points. Now it has to hold above 22650 zones to witness an up move towards 22850 and 23000 zones while on the downside support exists at 22600 and 22500 zones.

Derivative Outlook:

- Nifty future closed positive with gains of 0.30% at 22804 levels. Positive setup was seen in VEDL, Mcdowell, NMDC, Concor, Aartiind, Petronet, MCX, Indigo, Coal India, Trent, IDFC, Tatachem, Page Ind, IDFC First Bank, Federal Bank, ITC, Kotak Bank, SRF, Hindalco, Bhartiartl, Voltas, SBIN, Eicher Motor, IRCTC and CUB while weakness in Tatacomm, Cipla, HDFC Life, Shree Cement, Alkem and Havells.
- India VIX was down by 2.20% from 11.36 to 11.11 levels. Volatility has been falling from the last two months and is supporting the buy on decline stance in the market.
- On weekly front, Maximum Call OI is at 23200 then 23000 strike while Maximum Put OI is at 22700 then 22300 strike. Minor Call writing is seen at 23300 then 23100 strike while Put writing is seen at 22700 then 22500 strike. Option data suggests a broader trading range in between 22200 to 23000 zones while an immediate trading range in between 22600 to 22900 zones.

- Ramco Systems Wins Multi-Million Dollar Deal From Korean Air Ramco Systems won a multi-million dollar deal from South Korea's largest airline Korean Air for its aviation software Ramco Aviation Suite
- Reliance Infrastructure Supreme Court allowed the curative petition filed by the Delhi Metro Rail Corporation, challenging an order to pay Rs8,000 crore to the company's subsidiary, Delhi Airport Metro Express Private. The Apex court directed a refund of all the amounts paid by the DMRC
- Shyam Metalics Company established a new stainless steel hot rolled coils facility at its existing plant in Sambalpur, Odisha as a part of its expansion plan. The new facility will have a capacity of 0.3 million metric tons per annum and will specialize in the production of 200 and 400 series stainless steel hot rolled coils.

- European Market -- European stocks rose, buoyed by positive news in the technology sector and higher resources prices, before key US inflation data that will provide fresh clues about the Federal Reserve's policy outlook. UK, Germany and France Index gained by 0.5% each.
- Asian Market Asian stocks witnessed mixed bag. Japanese stocks fell, snapping a two-day gain, as investors assessed the risk of further interest-rate hikes this year in Japan and kept an eye out for key inflation data due later today in the US. Hong Kong Index gained
