Market Update



Nifty: 22,419.95 -150.40 (-0.67%) Sensex: 73,730.16 -609.28 (-0.82%)

- Equity benchmark Nifty snapped 5-day winning streak on account of profit booking on financials, banking, and auto stocks.
- Nifty slipped 150 points or 0.7% to close at 22420. Bajaj Finance, Bajaj Finserv, Maruti, M&M, L&T and Kotak Bank were major loser among the Nifty stocks. However, there was outperformed in the boarder market as action shifted to Nifty mid-cap and small cap stocks.
- Nifty 500 stocks' advance decline ratio was 1.1:1. Both Nifty mid-cap and small cap index gained nearly 1% each. Large stocks witnessed profit booking due lower than expected quarterly results announced by Bajaj Finance. Bajaj Finance decline 8% to close at Rs6730.
- Among the Global market, Asian market, European market and US Future gained between 1-2% following blockbuster earnings from Microsoft Corp. and Alphabet Inc
- Rail stock witnessed fresh buying on hope of good quarterly results. IRFC, IRCON International, IRCTC, RVNL and Railtel gained between 2-5%.

- Vedanta demerger likely to get nod from lenders by May end Company likely to give their approval for the revenue stream-wise demerger of Vedanta by the end of May, a senior executive at the natural resources conglomerate told ET.
- PE Advent International queues up for a stake in Apollo 24/7 US private equity fund Advent International is among investors in discussions to acquire a minority stake in Apollo 24/7, the digital healthcare platform of Apollo Hospitals, said two people aware of the development. The buyer is likely to invest about Rs 2,100 crore (\$250 million), valuing the subsidiary at about Rs 17,000 crore (\$2 billion).
- Bata India Company's board approved the proposed sale of its Faridabad Land in favor of Amolik Buildcon LLP for Rs156 crore.
- Zydus Life Company received a final approval from the USFDA to market Tretinoin Cream USP to treat acne.
- Sandur Manganese Company is to acquire 80% stake in Arjas Steel Pvt. at an enterprise value of Rs 3,000 crore. Promoter entity BAG Holdings will also acquire 19.12% stake in Arjas Steel.
- Maharashtra Bank Q4 NII Rs2548cr (up 18% YoY), Net profit Rs1220cr (up 45% YoY), GNPA 1.88% vs 2.04% (QoQ), Provision Rs942cr (up 19% YoY), Operating Profit Rs2210cr (up 19% YoY), NPA 0.0% vs 0.22% (QoQ) and dividend Rs1.40 a share
- Bajaj Finserv Q4 Total Income rose 35.62% (YoY) to Rs 32,042 crore and Net profit rose 19.78% to Rs 2,119 crore
- Supreme Industries Q4 Results Revenue up 16% (YoY) at Rs 3,008 crore. Ebitda up 2% (YoY) at Rs 491 cr. Ebitda Margin down 215 bps at 16.31% from 18.47%. Net profit down 1% (YoY) at Rs 355 crore
- CSB Bank Q4 results NII rose 11% (YoY) Rs 386 crore, Net profit fell 3% (YoY) to Rs 151.5 crore, Gross NPA at 1.47% vs 1.22% (QoQ) and Net NPA at 0.51% vs 0.31% (QoQ)
