Crude Oil Fundamental Update

- Brent oil tumbles below \$75 a barrel, erasing all year-to-date gains.
- Prices came under pressure amid potential resolution of a dispute in Libya that has caused a halt in country's crude production and exports
- Worries about China-led crude demand weakness weighed on sentiment amid signs of struggle to boost economic growth
- China Mfg. PMI remained weak with data of new export orders falling for first time in eight months in July
- China's crude imports dropped to 9.97 Mbpd in July, the lowest on a daily since Sep 2022
- European economies have also struggled, while growth in the US has slowed down markedly
- U.S. Summer driving season, a boon for crude demand was a lacklustre event
- Speculation over eight leading OPEC+ producers would unwind their voluntary production cuts pressured prices
- Eight OPEC+ members are scheduled to boost output by 180,000 barrels per day (bpd) in October
- Should oil prices fall further, then OPEC will have a big decision to make
- Prices are expected to remain lower as demand concerns are a major drag, however any surprise cut from OPEC might give temporary push to prices.

MCX Crude Technical Update



- MCX Crude Oil prices have decisively breached below the upward sloping trend line of the Symmetrical Triangle pattern on weekly chart which was observed at Rs. 6070 level. The fall is likely to extend towards the March 2023 lows of Rs. 5280 levels.
- The 14-period RSI on daily chart has fallen below 60 mark which signals bearishness in the counter. The key resistance is observed at 20-days moving average which is placed near Rs. 6350 level.
- We recommend to create short positions in the counter at Rs. 5980 and add on rally towards Rs. 6070, with a stop loss above Rs. 6350 level on closing basis with expected targets towards Rs. 5400 and Rs. 5280 levels.

NYMEX Crude Technical Update



- WTI Crude prices have breached below the key support of upward sloping trend line of symmetrical triangle on weekly chart which was placed near \$72 level. The fall is likely to extend towards the March 2023 lows of \$63.50 level.
- The 14-period RSI on weekly chart has fallen below 60 mark which signals bearishness in the counter. Key resistance is observed at 20-days moving average which is placed at \$75 level.
- We recommend to create short positions in the counter at current price \$70.80 and add further positions towards \$72 level for lower targets of \$64 and \$63 levels. Our view will be negated if prices break above \$75 level on closing basis.
