- Market is expected to open on a positive note due to strong performances in Asian markets, a notable rally in US markets overnight, and a sharp decline in oil prices from a two-month high.
- Attention will be on the RBI's credit policy announcement today, while IT giant TCS will reveal its Q2 results tomorrow. US markets gained with increases up to 1.5%, largely driven by tech sector.
- There is a consensus that the RBI is likely to maintain interest rates, but its commentary will be crucial for market sentiment.
- Focus on banks, real estate, NBFC and auto stocks ahead of RBI policy outcome today and RBI governor commentary.

Senco Gold: CMP INR1375 TP INR1700 Upside 24% Buy

- Senco Gold (SENCO) released its pre-quarterly update for 2QFY25
- Retail growth was robust at 27% in 2Q YoY (in line) and 19% in 1H YoY. SSG growth substantially improved to 20% in 2Q (est. 20%) vs. 4% in 1Q, yielding 12% SSG growth in 1H.
- SENCO plans to launch 18-20 jewelry showrooms, including 10-12 franchisees in FY25, with 8 already launched in H1.
- Gold prices rose 5% QoQ and 31% YoY, while silver prices rose 3% QoQ and 30% YoY.
- Good monsoon in Eastern India acted as a tailwind for robust growth in tier 3 and tier 4 cities. The reduction of custom duty by 9% (15% to 6%) in Jul'24 also bolstered the pent-up demand of Q1

Tata Power: CMP INR456 TP INR530 Upside 16% Buy

- Tata Power is pursuing bids for wind turbines to equip its wind-solar hybrid renewable energy projects, expecting to install over 3GW with a potential expansion to 5GW over five years. The investment is estimated about \$9bn.
- Tata Power is undergoing a multi-year structural shift that will, over time, lower earnings volatility, improve balance sheet strength and lower commodity exposure.
- Management aims to double the company's EBITDA and PAT by FY27, which implies a ~19% CAGR in EBITDA/PAT over FY23-27 period.

- Stock is in overall uptrend and holding gains at higher zones. It is on the verge of giving range breakout on daily chart above 6036 zones.
- It has formed a strong bullish candle on daily chart and gave highest daily close ever. The momentum indicator RSI has given bullish crossover which may confirm the up move.



- Nifty October future closed at 25,131.65 with a premium of 118.50 point v/s 189.80 point premium in the last session.
 - Nifty futures OI increased by 1.78% to 1.59 Cr and Bank Nifty futures OI decreased by 2.21% to 34.07 Lakhs.
 - Nifty Put/Call Ratio (OI) increased from 0.67 to 0.74 level.
 - On option front, Maximum Call OI is at 26000 then 27000 strike while Maximum Put OI is at 24000 then 25000 strike. Call writing is seen at 25000 then 25200 strike while Put writing is seen at 25000 then 24000 strike. Option data suggests a broader trading range in between 24500 to 25500 zones while an immediate range between 24700 to 25300 levels.
