MOSt MARKET ROUNDUP



Market Update



Nifty: 24,964.25 -34.20 (-0.14%)

Sensex: 81,381.36 -230.05 (-0.28%)

- The Nifty ended slightly lower, down 34 points or 0.14%, closing at 24,964. This dip was influenced by above-expected US inflation data and continued selling from foreign institutional investors (FIIs), which dampened market sentiment. While the overall market remained range-bound, there was notable stock and sector-specific activity.
- The IT sector saw buying interest, driven by hopes for strong quarterly results, although TCS's report fell short of Q2 estimates, resulting in a 2% decline to 4,149. Conversely, stocks like Persistent Systems, HCL Tech, Tech Mahindra, and Coforge rose between 1-5%.
- Metal stocks gained approximately 1%, buoyed by rising base prices on the London Metal Exchange (LME) and anticipation of a stimulus announcement from China. Key performers included SAIL, Hindalco, National Aluminium, and Tata Steel, all up between 1-3%.
- The broader Asian and European markets exhibited mixed results as investors awaited further details on China's potential stimulus measures later this week. Overall, despite the minor decline in Nifty, certain sectors, particularly metals and IT, showed resilience and specific growth.

Technical Outlook:

- Nifty Index opened negative and moved within a narrow band of around 100 points throughout the session. Momentum was missing on either sides and the index has been moving in a lackluster manner from the last three sessions.
- It formed a Doji sort of candle daily frame and a small bodied bearish candle on weekly frame. Now till it holds below 25150 zones, weakness could be seen towards 24850 then 24750 zones whereas hurdles are placed at 25150 then 25350 zones.

Derivative Outlook:

- Nifty future closed negative with losses of 0.28% at 25048 levels. Positive setup in Nationalum, Persistent, Exideind, Ipca Labs, MCX, Divislab, Tatachem, Trent, OberoiRlty, Page Ind, Hindalco, Glenmark, Hcltech, Dixon, Motherson, HDFC AMC, Infy and Siemens while weakness in Cumminsind, Cipla, ICICI Bank, TCS, Manappuram, AU Bank, Powergrid and Asian Paint.
- On option front, Maximum Call OI is at 26000 then 25000 strike while Maximum Put OI is at 25000 then 24000 strike. Call writing is seen at 25000 then 26000 strike while Put writing is seen at 24950 then 24900 strike. Option data suggests a broader trading range in between 24500 to 25500 zones while an immediate range between 24700 to 25200 levels.
