### **Clarus: Monthly Commentary**

- Nifty corrected 2% in December, ending CY24 with a modest 10% return. Mid-cap and small-cap indices outperformed, gaining 1.4% and 0.6% in December, and delivering strong 25% returns for the year
- Large-cap stocks continued to underperform, weighed down by weak earnings growth and FPI outflows
- Energy (-6.1%) and Commodities (-4.9%) were the worst performing sectors, while Pharma (+5.3%) and Realty (+3.2%) outperformed the broader market
- In 2024, FPIs have sold ₹127k cr (\$15.2 bn) of Indian equities in the secondary market but bought an equivalent ₹121k crore (\$14.4 bn) in new issuances in the primary market. Meanwhile, DIIs remained active buyers, purchasing equities worth ₹527k cr (\$62.9 bn) in CY24
- Clarus outperformed the market with a modest decline of 1.3% in December, driven by healthy performance from companies in the Healthcare and IT sectors. For CY24, Clarus delivered a return of 25.1%, significantly outperforming the BSE 500, which returned 15.8%

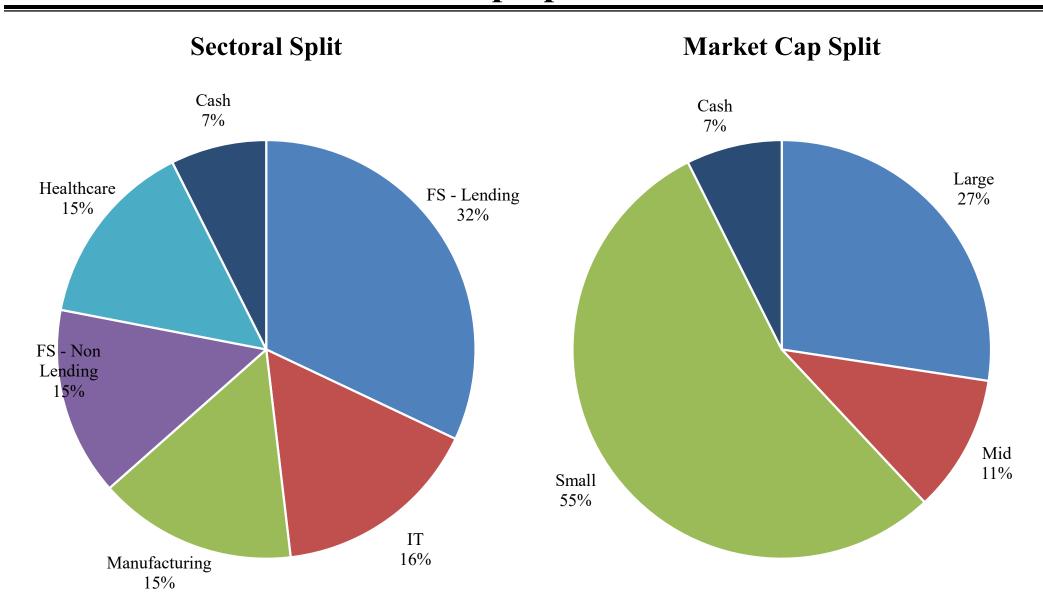
