Zinc Zone Ahead!!!

Fundamental Update



- Zinc prices have been rising MoM in the range of 2-3% since three consecutive months
- LME zinc stocks fell below 100000 tonnes, offering support to prices
- China's industry ministry pledged to stabilize growth in key sectors such as machinery, autos, and electrical equipment
- The market shifted to a 44,100-tonne deficit in May, from a 17,300-tonne surplus in April (ILZSG)
- Prices surged mid-July due to tight inventory, warrant cancellations, and speculative buying
- Hedge funds, investment banks and institutional investors captured the opportunity to increase their long position to conduct arbitrage over calendar spread
- China's industry ministry pledged to stabilize growth in key sectors such as machinery, autos, and electrical equipment which may further boost demand for metals
- Dollar faced some pressure following a weaker-than-expected July jobs report, which strengthened market expectations for a Federal Reserve rate cut in September
- Although, Chinese manufacturing PMI contracted for a second month in a row
- We expect zinc prices to deliver an upside of 4-5%.

MCX Zinc Technical Update



- MCX Zinc on the daily chart has broken out of a falling channel pattern, followed by a successful retest, and is now reversing to the upside, indicating a continuation of the ongoing bullish trend.
- Price action maintains a classic uptrend structure, consistently forming higher highs and higher lows.
- Therefore, we recommend buying in the range of ₹265 – ₹266, with a stop-loss *below* ₹256 on a closing basis and upside targets at ₹284

LME Zinc Technical Update



- LME Zinc on the daily chart has also broken out above a falling channel pattern, completed a retest, and is now turning higher, reaffirming the continuation of the broader bullish trend.
- The price action continues to reflect a classic bullish setup, characterized by a steady formation of higher highs and higher lows.
- So, we recommend to buy in current range of \$2,760 – \$2,770 with stop loss *below* \$2,665 level on sustainable basis and with an upside targets at \$2,960 levels
