## BSE SENSEX : 82693

The S&P BSE Sensex index opened on a positive note and swiftly advanced in the initial half hour crossing 82500 marks. Thereafter it traded sideways within a tight range of 200 points witnessing high volatility through the session. On the daily chart it formed a bullish candle signalling renewed buying interest at lower levels. The index eventually wrapped up the day with respectable gains of around 310 points. Now it has to hold above 82500 zones for an up move towards 83100 then 83300 zones while supports have shifted higher to 82500 and 82200 zones.

**Expiry day point of view :** Overall trend is likely to remain positive and now it has to hold above 82500 zones for an up move towards 83100 then 83300 zones while supports have shifted higher to 82500 and 82200 zones.

**Trading Range :** Expected wider trading range : 82200/82500 to 83100/83300 zones.

**Option Strategy :** Option traders can initiate weekly Bull Call Spread (Buy 82800 CE & Sell 83000 CE) to play the upside move.

**Option Writing :** Option writers are suggested to Sell 81600 Put & 83800 Call in pair with double the SL.

**Weekly Change :** S&P BSE Sensex is up by 1.38% at 82693 on a weekly basis. Sensex VWAP of the week is near 82540 zones and it is trading 150 points above the same which indicates positive bias with buy on dips stance for expiry day point of view.
