NCDEX Guarseed prices declined by -0.73% in the previous week. It recorded the high of Rs. 4831 and low of Rs. 4663 throughout the week. Key immediate support is held at Rs. 4600 level whereas significant resistance is placed at Rs. 4850. On the daily chart, it is trading below 20 day SMA level. The 14-period RSI is trading below the mid-point of 50 mark on the daily chart suggesting a strength in the momentum towards downside. There is a possibility for it to test 4450 on the lower side till it holds below 4950.



Guar Gum

NCDEX Guargum prices gained by 1.20% in the previous week while touching the high of Rs. 8696 and low of Rs. 8410 level. Key immediate support is held at Rs. 8200 level whereas significant resistance is placed at Rs. 8800. On the daily chart, it is trading below 20 day SMA level. The 14-period RSI is trading below the mid-point of 50 mark on the daily chart suggesting a strength in the momentum towards downside. There is a possibility for it to test 8200 on the lower side as long as prices are holding below 8800.



NCDEX Turmeric prices declined by 5.02% in the previous week. It dropped to a low of Rs. 14046 and a high of Rs. 15658 level. The vital immediate support is now seen at Rs. 13500 mark. However, the key immediate resistance is placed at Rs. 14900 level. On the daily chart it is trading below the 20 day SMA level. The 14-period RSI is hovering around the mid-point of 50 mark on the daily chart suggesting a range bound move. The overall bias remains in the broader range 14900 - 13500. NCDEX Turmeric has extended its bullish momentum after a decisive breakout from the long-term descending channel, confirming a clear trend reversal from bearish to bullish. The sharp up move from ₹11,620 propelled prices well above both the channel resistance and the 20-day EMA, showcasing strong buying interest.



NCDEX JEERA prices gained by 2.17% in the previous week while recording high of Rs. 20800 and low of Rs. 20065 level. The critical support is noted at Rs. 19500 level however key immediate resistance is placed at Rs. 21900 mark. On the daily chart, it is trading below 20 day SMA level. The 14-period RSI is trading above the mid-point of 50 mark on the daily chart suggesting a strength in the momentum towards upside. There is a possibility for it to test 21900 on the higher side as long as prices are holding above 19500.
