**NIFTY : 26013**

Nifty index opened positive and continued buying cues from where it left in the previous week and soared to cross 26k marks. It witnessed a gradual up move throughout the day and the index was seen repeatedly finding support at minor retracements. It formed a bullish candle on the daily frame and finally closed near its day's higher band with gains of around 100 points after successfully defending any intermediate pivots. Now it has to hold above 25900 zones for the next up move towards 26150 then 26277 zones while supports can be seen at 25900 then 25800 zones.

**Expiry day point of view :** Overall trend is likely to be positive to range bound and Now it has to hold above 25900 zones for the next up move towards 26150 then 26277 zones while supports can be seen at 25900 then 25800 zones.

**Trading Range :** Expected wider trading range : 25800/25900 to 26150/26277 zones.

**Option Strategy :** Option traders can initiate weekly Nifty Bull Call Spread (Buy 26050 CE and Sell 26150 CE) to play the upside.

**Option Writing :** Sell weekly Nifty 25800 PE and 26250 CE with strict double SL.

**Weekly Change :** Nifty is up by 1.24% at 26013 on a weekly basis. Nifty VWAP of the week is near 25900 levels and it is trading 100 points above the same which indicates bullish bias for the expiry day point of view.
