BSE SENSEX : 77958

S&P BSE Sensex index opened with a gap up but failed to sustain at higher levels and drifted lower towards 76800 zones in the initial hour of the session. Later strong buying interest emerged at lower levels which led to recovery towards 78000 zones. It managed to hold its gains and ended the session with gains of around 940 points. It formed a bullish bodied candle on the daily scale with a long lower wick indicating buying interest at lower levels. Now it has to hold above 77700 zones for an up move towards 78500 then 78700 levels while support is placed at 77700 then 77500 zones.

Expiry day point of view : Overall trend is likely to remain positive and now it has to hold above 77700 zones for an up move towards 78500 then 78700 levels while support is placed at 77700 then 77500 zones.

Trading Range : Expected wider trading range : 77500/77700 to 78500/78700 zones.

Option Strategy : Option traders can initiate weekly Bull Call Spread (Buy 78300 CE & Sell 78600 CE) to play the upside move.

Option Writing : Option writers are suggested to Sell weekly 77000 Put & 79500 Call in pair with double SL.

Weekly & Monthly Change : S&P BSE Sensex is up by 1.36% on a weekly basis. Sensex VWAP of the week is near 77550 levels and it is trading 410 points above the same which indicates overall bullish stance with buy on dips for the expiry day point of view.
