



Guar Seed

NCDEX Guarseed has witnessed profit booking after testing the ₹6,400 resistance, with prices slipping back below the upper boundary of the rising wedge pattern. However, the contract is still trading above the 20 EMA, suggesting that the broader trend remains positive despite the short-term correction. The immediate support is placed at ₹6,000. As long as this level holds, the ongoing decline may remain corrective and prices could attempt another move towards ₹6,400, followed by ₹6,650. However, a decisive close below ₹6,000 could increase selling pressure and drag prices towards the next support at ₹5,800. Overall, the medium-term outlook remains constructive while prices hold above ₹6,000, whereas a sustained move below this level may indicate a deeper correction within the rising wedge structure.



Guargum

NCDEX Guargum has witnessed sharp profit booking after testing the ₹12,700 resistance, with prices slipping below the upper boundary of the rising channel. Despite the recent correction, the contract continues to trade above the 20 EMA, indicating that the broader trend remains positive while short-term weakness persists. The immediate support is placed at ₹11,800. As long as this level holds, the decline may remain corrective and prices could attempt a recovery towards ₹12,200, followed by ₹12,700. However, a decisive close below ₹11,800 may extend the correction towards the next support at ₹11,400. Overall, the medium-term outlook remains constructive while prices sustain above ₹11,800. A sustained move below this level could signal a deeper correction, whereas a move back above ₹12,200–₹12,700 would strengthen the bullish momentum within the rising channel.



Jeera

NCDEX Jeera is approaching the upper boundary of a symmetrical triangle, with prices trading above the 20 EMA, indicating improving bullish momentum. The recent recovery suggests buyers are regaining control, but a decisive breakout above the pattern resistance is required to confirm further upside. The immediate resistance is placed at ₹21,000. A sustained close above this level could confirm the breakout and open the door for a move towards ₹21,500. On the downside, ₹20,000 remains the key support. As long as prices hold above this level, the positive bias is likely to remain intact. However, a close below ₹20,000 could trigger renewed selling pressure towards the next support at ₹19,500. Overall, the short-term outlook remains cautiously bullish while prices sustain above ₹20,000, with a breakout above ₹21,000 likely to strengthen the bullish trend.



Turmeric

NCDEX Turmeric has delivered a strong breakout above the neckline of a Cup & Handle pattern, confirming a bullish continuation on the weekly timeframe. The sharp move above the ₹19,800 resistance with prices holding well above the 20 EMA reflects strong buying momentum and suggests the broader uptrend remains intact. The breakout level at ₹19,800 now acts as the immediate support. As long as prices sustain above this level, the rally is likely to extend towards ₹24,000, followed by the next major resistance at ₹26,500. Any short-term pullback towards the breakout zone may attract fresh buying interest. Overall, the medium-to-long-term outlook remains strongly bullish while prices hold above ₹19,800. A sustained move below this level would weaken the breakout structure and could trigger a corrective decline towards ₹17,500, but the prevailing trend continues to favor the upside.
