NIFTY: 24774

Nifty index opened with a gap up of around 190 points and remained in a narrow range of 100 points throughout the session. The index was sustaining at higher levels amidst the rangebound day. It formed a strong bullish candle on the daily frame and has been making higher highs - higher lows from the last seven trading sessions. Now it has to hold above 24600 zones for an up move towards 24800 then 25000 zones while support can be seen at 24500 then 24400 zones.

Expiry day point of view : Overall trend is likely to be positive and now it has to hold above 24600 zones for an up move towards 24800 then 25000 zones while support can be seen at 24500 then 24400 zones.

Trading Range : Expected wider trading range : 24400/24500 to 24800/25000 zones.

Option Strategy : Option traders can initiate weekly Nifty Bull Call Spread (Buy 24550 CE and Sell 24650 CE) to play the buy on dips.

Option Writing : Sell weekly Nifty 24400 PE and 24750 CE with strict double SL.

Weekly Change : Nifty is up by 3.29% at 24774 on a weekly basis. Nifty VWAP of the week is near 24400 levels and it is trading 370 points above the same which indicates overall bullish stance with buy on dips for the expiry day point of view.
